The following companies are authorized to take fingerprints for civil purposes and submit them as electronic transactions to RCMP's Canadian Criminal Real Time Identification Services for verification against the National Repository of Criminal Records.

The list is updated at the beginning of each month. It is subject to change as companies can be added or removed at any time.

### Note

Companies that have been officially recognized can ask the Canadian Criminal Real Time Identification Services not to reveal their company's whereabouts if they prefer to keep that information private.

### Note

There are no private fingerprinting companies accredited by the RCMP outside of Canada.
